Dear Mr. Hubbard,

Thank you for reviewing the Florida Department of Transportation, District Four (FDOT-4) Palm Beach County Cycle 3 Year 2 Annual Report and providing the request for additional information. It was noted in the SWMP Inspection Schedule section of the report that FDOT-4 "did not inspect ditches".

Per the FDOT Statewide Stormwater Management Plan (SSWMP), Table 3-1, Item 12, the inlets, catch basin grates, ditches and other stormwater conveyances are inspected through the Statewide Maintenance Rating Program (MRP).

When filling out page 4 of the Annual Report Form, a value of "0" was erroneously placed in the "Number of Inspections" column for ditches/conveyance swales. The value should have read "MRP", consistent with similar MS4 components inspected through this program, such as pipe/culverts and the inlets/catch basins/grates structure types. The comments section of the ditches/conveyance swales structure type accurately refers to Section 3.7.1 of the SSWMP.

We apologize for any confusion this may have caused. Please see Attachment A for the corrected page of the Annual Report form.
